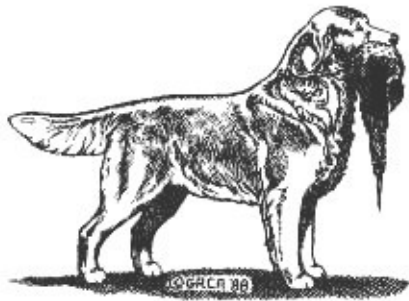

Over the course of the next few years, farsighted members successfully steered the club through the AKC approval processes by holding sanctioned matches and field events, and progressing to licensed specialty shows, obedience trials, hunting retriever tests, and tracking tests. GRCA-sponsored events have also been held and include working certificate tests, field trials, and regional and national events.

Our club meets at 7:30 pm on the third Wednesday of the month at least eight times a year at the AKC Museum of the Dog, 1721 S. Mason Rd., St. Louis, MO 63131. In **April** we hold our Annual Awards Ceremony and in **December** we have a Christmas party in lieu of business meetings.
